WHEREAS, the Client wishes to have the Consultant perform the services hereinafter referred o, and

WHEREAS, the Consultant is willing to perform these services,

NOW THEREFORE THE PARTIES hereby agree as follows:

1. Services

- (i) The Consultant shall perform the services specified in Annex A, "Terms of Reference and Scope of Services," which is made an integral part of this Contract ("the Services").
- (ii) The Consultant shall provide the personnel listed in Annex B, "Consultant's Personnel," to perform the Services.
- (iii) The Consultant shall submit to the Client the reports in the form and within the time periods specified in Annex C, "Consultant Reporting Obligations."

The Consultant shall perform the Services during the period commencing [April 9<sup>th</sup> 2014] and continuing through [April 30<sup>th</sup> PAKISTAN 2014], or any other period as may be subsequently agreed by the parties in writing.

Payment.

Ceiling

For Services rendered pursuant to Annex A, the Client shall pay the Consultant an amount not to exceed [PKR. 10,905,804/-]as specified in Annex D. This amount has been established based on the understanding that it includes all of the Consultant's losts and profits as well as any tax obligation that may be imposit on the Consultant.
