AGENDA:

To select reputable research firms to conduct standard verification survey of 4567 schools / applications in the history of Sindh Education Foundation in accordance with the PC-I of Integrated Education Learning Program.

## PROCESS:

- 1- Tender Advertisement to conduct verifications survey was published on 7<sup>th</sup> February 2010 in national newspapers (JANG, DAWN, KAWISH, IBRAT) to pre-qualify the prospective research firms.
- 2- Following competent outsource experts of education sector were invited to conduct short-listing of research firms:
  - 2.1 Mr. Mohsin Tejani, President, Society for International Education, i-EARN, Pakistan,
  - 2.2 Mr. Sajid Ali, The Agha Khan University-Institute of Educational Development, Pakistan,
  - 2.3 Mr. S. Naeem Ahmed, Assistant Professor, Hamdard University, Pakistan,
  - 2.4 Mr. Noman Ul Haque Siddiqui, Sr. Manager (R,M&E), SEF, GoS, Khi,

3- To evaluate the reputable & capable research firms from the pool of applicant firms, following short listing criteria for research firms were adopted:
